Annual auto-renew

By choosing this option, you authorize HSLDA to automatically collect payment at the end of your 12-month membership and automatically renew your membership for the following 12-month period. If your discount group status has changed, you will be charged the appropriate amount.

- **If using debit/credit card**—HSLDA will charge your first payment immediately and debit subsequent payments within 1–3 business days of your membership anniversary.
- **If using direct debit only**—HSLDA will initiate electronic fund transfer in the form of preauthorized check withdrawals (debits) from your account at the financial institution written on your check, debit your first payment immediately, and debit subsequent payments within 1–3 business days of your membership anniversary date. (Returned payments subject to \$20 service fee.)

Monthly auto-pay

TERMS FOR BOTH AUTOMATIC PAYMENT OPTIONS:

- Payments can only be made by direct debit or by credit/debit card. Money orders cannot be used for any form of recurring membership.
- These options can be cancelled only after the 12th month.
- This authority is to remain in full force and effect until HSLDA has received from you written notification, including your HSLDA account number, of its termination in such time and in such manner as to afford HSLDA reasonable opportunity to act on it. You understand that membership is for a minimum term of one year.
- Payment updates must be received a minimum of 4 business days prior to your payment date and must include your HSLDA account number.
- If your account is deactivated or if you change your membership option (including conference pricing or promotional offers, etc.), you will be subject to future prevailing membership prices.
- Auto-renew is not available with any promotional pricing.
- As long as your membership remains active, your membership dues will not be subject to price structure increases.
- HSLDA reserves the right to change these terms at any time.

- F. You will receive your membership cards after your application is approved. Membership is valid from the date your application is processed.
- G. Your membership includes a free subscription to the *Home School Court Report*.
- H. HSLDA reserves the right not to accept any membership application and the right to revoke membership if any information has been misrepresented. If your application cannot be approved, we will return your payment.
- I. Membership services are not available in connection with any child enrolled full-time in a public school or government-supported program based in the home, such as a charter school, virtual charter school, or independent study program.
- J. HSLDA does not provide legal representation for members in matters involving divorce, child custody, or related domestic disputes.
